The MFHF will select judges from the Army, Navy, Air Force, Marine Corps, Coast Guard and Defense Logistics Agency services to validate each submission for justification for induction, to either the Hall of Fame or Lifetime Achievement categories. ***Nominee packages must arrive at the Military Firefighter Heritage Office by Monday, 11 February 2019. Inductees will be notified NLT 22 March 2019.***

2019 Lifetime Achievement & Hall of Fame Awards Criterion

The criteria for the awards are listed in items #1 Hall of Fame and item #2 for Lifetime Achievement below. Keep in mind the accomplishment(s) of the individual and the impact that they had on your branch's Fire and Emergency Services section and/or on the Fire and Emergency Services community.

1. Hall of Fame Award;

- a. Individual must have completed at least 10 years of service to Military Fire and Emergency Services (provide service dates on nominee package) or committed an act of extreme merit.
- b. Packages will be scored by a Selection Committee panel comprised of individuals who are external to the MFHF board and its committee members. All nominations shall be submitted in a word document in Times New Roman "12" font. Nomination shall be no more than thirty (30) lines in either bullet or narrative format. Headings shall read:
 - i. "SINGLE ACT"
 - ii. "LEGACY TO F&ES, to include:

1. "PROFESSIONAL ACHIEVEMENTS"
 2. "CONTRIBUTIONS TO DOD F&ES"
- c. Nominator's are not limited to individuals from their respective service component.
- d. Nominee criteria are the following:
- i. Nominee may be retired or still be serving as a member of the Fire Service.
 - ii. Nominee packages must arrive at the Military Firefighter Heritage Office by Monday, 11 February 2019.
 - iii. Nominee package must include:
 - iv. Complete name of the nominee to include middle initial
 - v. Current address, phone number and e-mail address (if available)
 - vi. Current and previous military Fire and Emergency Services affiliations with dates of service
 - vii. Nominee summary of fire service experience/position(s) held
 - viii. Nominee professional accomplishments and distinguished service
 - ix. Nominee education, training and/or certification achievements
 - x. Nominee awards (previous awards)
 - xi. Impact Inductee had on the Fire and Emergency Services branch/community.
- e. A maximum of five (5) winning nominations receiving approval from the selection committee will be inducted in the Hall of Fame. The Lifetime Achievement Award recipient shall be inducted into the Hall of Fame for a total of six (6), if they have not already been honored in the Hall of Fame.
2. The Lifetime Achievement Award will follow the same criteria in item # 1 with the exception of the following:
- a. Individual must have completed at least 30 years of service to Military Fire and Emergency Services (provide service dates on nomination package). If 30 years have not been met, justified reason must be attached. *NOTE: there will be only one individual selected for the Lifetime Achievement Award.*
 - b. Packages will be scored by a Selection Committee panel comprised of individuals who are external to the MFHF board and its committee members. Submissions shall

- be in a word document written in Times New Roman “12” font. Nomination shall be no more than fifty (50) lines in either bullet or narrative format. Headings shall read:
- i. “PROFESSIONAL ACHIEVEMENTS”
 - ii. “CONTRIBUTIONS TO F&ES”
 - iii. “COMMUNITY LEADERSHIP & INVOLVEMENT”.
- c. Nominee packages must arrive at the Military Firefighter Heritage Office by Monday, 11 February 2019.
3. The Military Firefighters Heritage Foundation Awards Committee reserves the right to review and overall approve the Selection Committee's Inductee selections for the Hall of Fame and Lifetime Achievement Awards. Additionally, the Lifetime Achievement award recipient shall be automatically inducted into the Hall of Fame. Finally, the committee also reserves the right to disapprove an Inductee package if sufficient information was not provided.
 4. Inductee's will be honored at the Annual Military Firefighters Heritage Foundation Annual Event, held 3 May of 2019. All inductees will be notified NLT 22 March 2019, so if they would like to attend the 2019 Firefighter Ball, they can make travel arrangements. This year's Firefighters Ball will be held at the San Angelo, McNease Convention Center 3 May at 6:00 p.m. The dress will be Semi-Formal.
